

Terms and conditions for Blisters for Bread 2019 - Lucky Star Hamper Promotion

- 1 This is a promotional competition called Blisters for Bread 2019 - Lucky Star Hamper Promotion (the "Competition") conducted by Lucky Star Ltd (Registration Number: 1946/022718/06) of 8th Floor, Oceana House, 25 Jan Smuts Street, Foreshore, Cape Town (the "Promoter") subject to the provisions of section 36 of the Consumer Protection Act, No. 68 of 2008 as amended ("CPA") and the regulations promulgated there-under, and the terminology used in the aforesaid CPA shall apply to the Competition.
- 2 This promotion is organised and run on behalf of the Promoter by LIFE brand communications (Registration no. 2014/006727/07) ("LIFE brand) of 25 Stanley Road, Rondebosch, Cape Town, represented by Warren Lodge.
- 3 Except for those participants described in section 36(3)(b) of the CPA (see clause 8 below), the Competition is open to individuals who have a South African identity number/valid passport/refugee documents, who are 18 years or older and are currently residing in the Republic of South Africa.
- 4 To enter the competition, participants must:
 - 4.1 go to the Blisters for Bread Facebook page or the Peninsula School Feeding Association's Facebook pages; and
 - 4.2 tell us they you are entering Blisters for Bread 2019 before 18 August 2019.
- 5 Prizes consist of one of 2 Lucky Star Hampers. The winning entry will be chosen by LIFE brand in its sole discretion.
- 6 The competition opens on 16 August 2019 and closes at midnight on 18 August 2019.
- 7 Winners will be announced on the Blisters for Bread and Peninsula School Feeding Association's Facebook pages by 20 August 2019.
- 8 The prizes shall not be awarded to a director, member, partner, employee or agent of, or consultant, or their spouse, partner or members of their immediate family, to the Promoter or any other person who directly or indirectly controls or is controlled by, the Promoter, or to a supplier of goods or services in connection with the competition. The Promoter reserves the right to request a winner to depose an affidavit confirming that he/she does not fall within this category of persons and must further upon request be able to verify their identity by providing a certified copy of their South African identity document, valid passport or formal refugee documentation.
- 9 Prizes are not transferable and will only be given to the winner and not a representative.
- 10 If for whatever reason the winner cannot be contacted or is disqualified in terms of clause 18 below, the prize will be forfeited to the Promoter for a reselection on the same basis that the original winners were selected.
- 11 By entering this competition, the participant acknowledges and agrees that the Promoter, its agents and representatives are granted the right to invite the participant, which invitation the participant has the right to decline, participate in any marketing activity and use the footage and/or images of the
