## Terms and conditions for Shoot Your Shot

- This is a promotional Competition called "Shoot Your Shot" (the "Competition") conducted by Lucky Star Limited (Registration Number: 1946/022718/06) of 8th Floor, Oceana House, 25 Jan Smuts Street, Foreshore, Cape Town (the "Promoter") subject to the provisions of section 36 of the Consumer Protection Act, No. 68 of 2008 as amended ("CPA") and the regulations promulgated there-under, and the terminology used in the CPA shall apply to the Competition.
- 2 Except for those participants described in section 36(3)(b) of the CPA (see clause 8 below), participants must be 18 years or older and must be citizens of South Africa and need to hold a valid South African ID document. Furthermore, participants must have a valid South African bank account.
- To enter the Competition participants must create a reel telling Lucky Star who their crush is and also why their crush should go on a date with them. The participants should then tag both Lucky Star and their crush #LuckyStarShootYourShot and submit their answers in the comments section which is #LuckyStarShootYourShot on Lucky Star's social media platforms (Twitter, Facebook and Instagram).
