Terms and conditions for "No electricity, No problem" – (Social Media)

- This is a promotional Competition called "No electricity, No problem" via social media (the "Competition") conducted by Lucky Star Ltd (Registration Number: 1946/022718/06) of 8th Floor, Oceana House, 25 Jan Smuts Street, Foreshore, Cape Town (the "Promoter"). This Competition is subject to the provisions of section 36 of the Consumer Protection Act, No. 68 of 2008 as amended ("CPA") and the regulations promulgated there-under, and the terminology used in the aforesaid CPA shall apply to the Competition.
- 2 Except for those participants described in section 36(3)(b) of the CPA (see clause 8 below), the Competition is open to individuals who have a South African identity number, are 18 years or older and are currently residing in the Republic of South Africa.
- 3 To participate in the Competition, participants are invited via social platforms to tell the Promoter what meal they will be making using one of the weekly picked ingredients which they will have to make without any electricity. The answer must be submitted via a social media platform.
- Two winners will be selected every week for a period of 5 (five) weeks. Each weekly winner will receive a Shoprite grocery voucher ("prize") to the value of R500.
- The Competition will commence on 8 March 2023 for a period of 5 (five) weeks and end at midnight on 09 April 2023 (Competition Period").
- 6 The total value of the prizes for the duration of the Competition Period amounts to R5000.
- The winner will be selected by 27Ten Concepts Social Media Manager and the Lucky Star brand team and will be notified of their prize via the social media platform in which they entered.
- The prize shall not be awarded to a director, member, partner, employee or agent of, or consultant, or their spouse, partner or members of their immediate family, to the Promoter or any other person who directly or indirectly controls or is controlled by, the Promoter, or to a supplier of goods or services in connection with the Competition. The Promoter reserves the right to request a winner to depose an affidavit confirming that he/she does not fall within this category of persons and must further upon request be able to verify their identity by providing a certified copy of their South African identity document, valid passport or formal refugee documentation.
